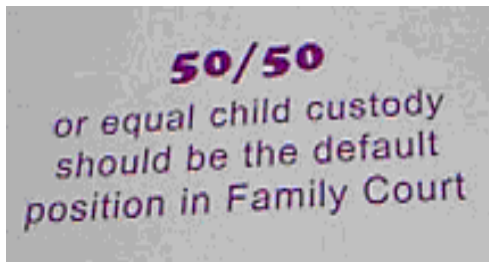

So, if you think that's the way it is. You are wrong.

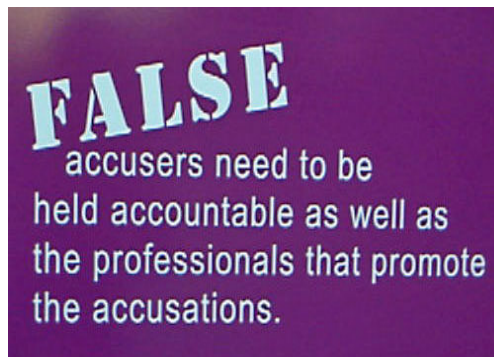


So, if you live in any state other than Iowa and are a parent; and if you and the other parent separate, one of you, usually the mother, has the advantage.

And so destructive that it harms everything it touches, particularly OUR children! DO NOT let anyone tell you that parental alienation does not exist, everyone but ideologues knows.

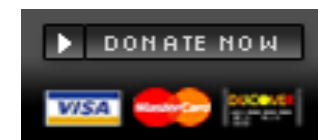

Why 50/50 shared parenting?

Every child has the right to grow up in the best possible, safe, and nurturing environment.

Abundant research shows that when children are removed from regular contact with one of their parents, they are placed at greater risk of a broad range of academic, emotional, behavioral, and criminal justice problems. Hence, financial, emotional, and physical aspects of child custody should be balanced, comprehensive, and in the best interests of all directly impacted by the process, the children AND the parents.

Generally, the best parents are decent and responsible biological parents, which is not always possible. Then loving and caring surrogate, step, and adoptive parents, particularly biological relatives are better than seriously abusive biological parents or no parents at all.

Grandparents and other responsible and loving consanguineal relations should at least have visitation rights and regular and frequent access to their grandchildren.

Equal/joint physical and legal custody should be automatic unless there is **evidence** of physical, sexual, or serious emotional abuse.
