

You should feel uncomfortable when reading this. While some would have us believe that making one feel "uncomfortable" is criminal, others believe in free speech, the exchange of ideas, and that the questioning of opposing views inherently involves becoming uncomfortable. You have the right to read or not read. No one is forcing you to read this. If you choose to read further and feel conflicted because of closely held beliefs, then you may wittingly or unwittingly be contributing to the politically correct disenfranchisement and premature death of males, one or more of whom you may love, perhaps even your son. If your beliefs are rigid and immune from critical thinking perhaps you should stop reading: or, for that matter perhaps you already have. What follows is only a beginning... 99.9% of COMBAT DEATHS ARE MEN whereas about 1,000 servicewomen have died in past wars beginning with the First World War (History and Collections Women in the Military Service for America Memorial Foundations, homepage). Males accounted for 93% of all U.S. worker deaths and had a work-related fatality rate approximately 12 times the rate for females (Fatal Occupational Injuries --- United States, 2005, Center for Disease Control). Similarly, APPROXIMATELY 76% OF HOMICIDE VICTIMS ARE MEN (Crime in the United States 2004, Department of Justice, and Federal Bureau of Investigation). 73% OF ALL SUICIDES IN THE UNITED STATES ARE WHITE MALES (Suicide in the United States, National Institute of Mental Health, 2003). "In fact, a divorced father is ten times more likely to commit suicide than a divorced mother, and three times more likely to commit suicide than a married father", according to Los Angeles divorce consultant Jayne Major (Distraught Father's Courthouse Suicide Highlights American's male Suicide Epidemic, by Glenn Sacks) AMERICAN WHITE MEN DIE FIVE YEARS EARLIER AND BLACK MEN ELEVEN YEARS EARLIER THAN AMERICAN WOMEN (National Center for Vital Statistics Deaths: Final Data for 2004, Center for Disease Control). It is estimated that over 80 percent of child abusers were under age 40 and that almost two-thirds (62%) were females. Additionally, 25% of sexual abuses, over 70 percent of neglect, and over 80 percent of medical neglect cases were associated with female perpetrators (*Child Maltreatment 1997: Reports from the States to the National Child Abuse and Neglect Data System*, U.S. Department of Health and Human Services). PATERNITY FRAUD IS ALMOST EXCLUSIVELY A CRIME PERPETRTED BY WOMEN (no source required). Half of domestic violence ("DV") victims are men. Although men are less likely than women to call police, randomized sociological (behavior-based) research consistently shows: (1) women initiate DV as often as men do; (2) women use weapons and surprise more than men do; and (3) about 38% of physically injured DV victims are men. (References Examining Assaults by Women on Souses or Male Partners: an Annotated Bibliography, by Martin S. Fiebert, Department of Psychology, California State University, Long Beach). Even the latest fact sheet from the Centers for Disease Control (partly from crime-based data) states: "In the United States every year, about 1.5 million women and more than 800,000 men are raped or physically assaulted by an intimate partner". Unfortunately, the DV industry has covered up female violence for decades for purely ideological reasons ("Disabusing the Definition of Domestic Abuse; How Women Batter Men and the Role of the Feminist State," by Linda Kelly, 30 Fl. St. U. Law R. 791, 2003). MYTHS KEEP GOOD FATHERS FROM GETTING PRIMARY CUSTODY OF CHILDREN MORE FREQUENTLY? "IT IS NOT TRUE that the majority of men who seek custody of their children get custody. IT IS TRUE that in contested custody disputes primary physical custody is awarded to the mother 90% of the time! DIVORCED DADS ARE NOT OVERWHELMINGLY DEADBEATS, DISAPPERING OR RUNAWAY DADS, ECONOMICALLY ADVANTAGED BY DIVORCE MORE THAN MOTHERS, SATISFIED OR ADVANTAGED IN NEGOTIATIONS LEADING TO THEIR DIVORCE SETTLEMENTS, CONTENT AND BETTER EMOTIONALLY ADJUSTED THAN MOTHERS, AND FATHERS DO NOT GENERALLY TRIGGER THEIR MARRIAGES DEMISE. SIXTY-THREE TO 67% OF DIVORCES ARE INITIATED BY WIVES (Divorced Dads, by Sanford L. Braver, PhD, page 133, - Divorced Dads is the end product of the largest study ever conducted about divorce in America). The number one reason for mothers to seek divorce is the "gradual growing apart, losing a sense of closeness (Braver, page 139). "VIOLENCE BETWEEN YOU (MOTHER) AND SPOUSE" ranks 16<sup>th</sup> on the list of reasons why women seek divorce (ibid); or, domestic violence doesn't even make it into the top ten. So, how did all those myths about fathers take root in westernized cultures? "[T]he components of the bad divorced dad image, arose largely from media stories and television and movie portrayals that were, with few exceptions, consistent with most existing social scientific consensus...past studies had some serious problems...problems that were sometimes activated by the ideological gender views of the researchers. According to gender stereotypes...women are basically good, gentle, self-sacrificing, and heroic...relatively powerless, and frequently victimized. Men...are powerful, irresponsible, and deceitful brutes" (Braver, pages 12-13). "[V]irtually every aspect of what I call the "bad divorced dad" image has turned out to be a myth, an inaccurate and damaging stereotype. Not only is this myth seriously inaccurate, it has led to harmful and dangerous social policies" (Braver, page 6). IF THEN, DIVORCE IS SO BENEFICIAL FOR MEN, WHY DO MEN EXPERIENCE OVER TWICE AS MUCH DEPRESSION, HOSPITAL ADMISSIONS, AND WORK PROBLEMS; OR, COMMIT SUICIDE FIVE TIMES MORE (ten times according to Jayne Major above) OFTEN THAN DO WOMEN (Braver, page 111)? There must be a reason "PARENTAL ALIENATION" (not the "syndrome") is referred to as "MALICIOUS MOTHER SYNDROME". And, WHAT ABOUT MONEY? WOMEN MAKE 88% OF RETAIL PURCHASES (53% of all stocks, 85% of toilet paper, 75% over-the-counter drugs, 90% greeting cards, 94% home furnishings, 65% of all cars, 80% of all health insurance, and, 60% of all self-help books-- the list of women first seems endless... "Demographers expect that by 2020, through inheritance, marriage, salary, or crook, women will control most of the money in America", (Pocketbook Power, How to Reach the Hearts and Minds of Today's Most Coveted Consumers - Women, by Bernice Kanner, page 6). AND, like other mainstream myths, some mainstream feminist appear to be misandrists, have never been married, have no children, abandoned traditional feminist beliefs grounded in equity, and are hell bent on destroying traditional families as well as America (inferred from a plethora of sources; see Women Who Make the World Worse: and How Their Radical Feminist Assault Is Ruining Our Schools, Families, Military, and Sports, by Kate O'Beime, for a good overview.) WHEN IT COMES TO CHOICE: Women can use abstinence, diaphragms, condoms, spermicides, implants, overnight pills, intrauterine device, abortion, adoption, return a baby to the hospital, keep the baby, give the baby away, sell the baby, contract to have a baby, auction the baby name any man she wants as the father with little or no repercussions if she fraudulently names the wrong man, and a women can with little fear of serious repercussions commit infanticide. MEN'S CHOICE: condoms, invasive surgery, cash, credit, bankruptcy, jail, and suicide. Abstinence does not work for men since any woman can name any man she chooses as a father to the children that she births. It's called PATERNITY FRAUD. "The American Association of Blood Banks says that the 300,626 paternity tests it conducted on men in 2000 ruled out nearly 30% as the father (Men wage battle on 'paternity fraud', Nation, 12/2/2002). It's rumored that PC pressure caused the AABB to take yearly paternity test result statistics off their website. HOW ABOUT RAPE? In *African-American Man*, historian Robin Kelly notes, "The 5,000 people who are lynched from 1880 and 1940, most of those are cases of black men accused of raping, or sexually assaulting women." PBS Home Video produced the Academy Award Nominated *Scottsboro an American Tragedy*, in which it is said, "In 1931, two white women stepped from a boxcar in Paint Rock, Alabama to make a shocking accusation: they had been raped by nine black teenagers on a train." Those false accusations sparked one of the most horrific judicial sagas in American herstory. Seventy-five years later came the equally sensational Duke Lacrosse Team rape case where all the victims were men and the accusing female again went free. But Legal Dominance Feminists insist that false reports account for only about 2 percent of rape complaints. "This purportedly empirical statement is ubiquitously repeated in legal literature...This empirical fact, however, is an ideological fabrication. As far as can ascertained, no study has ever been published which sets forth an evidentiary basis for the "two percent false rape complaint" thesis" (THE TRUTH BEHIND LEGAL DOMINANCE FEMINISM'S 'TWO PERCENT FALSE RAPE CLAIM' FIGURE, Edward Greer, Loyola of Los Angeles Law Review, Vol. 33:947, pages 947-948). Almost every month, DNA clears a falsely accused and convicted man after years of imprisonment for rape. A U.S. Air Force study found over one-fourth of women who accused men of rape recanted either just before taking or after failing a lie detector test - their most

common reason being "spite or revenge" - and it concluded 60% of the rape allegations were false (Forensic Science Digest, v. 11. n. 4, 12/85; Archives of Sexual Behavior, 1994, v. 23, n. 1.) NCFM believes that in contested divorce proceedings, false accusations of domestic violence or child abuse, and restraining order abuse, are all too common, though *reliable data* about frequency is scarce, arguably because political correctness prevents close scrutiny. Regardless, it is undeniable that without warning men are arrested, jailed, and barred from their homes, children, and resources based solely on unsubstantiated accusations and basic due process, which is fascism in its purest form disguised as victim rights. More than 50% of child sexual abuse allegations are unsubstantiated. (Eckenrode, Powers, "Substantiation of child abuse and neglect", Journal of Consulting & Clinical Psych., 1998, 56, 9-16; Lewis, "Reliability rather than zealotry," Summer 1996, Kentucky Bench & Bar, 60, 23-30.) False accusers are rarely prosecuted. Society pays a huge price for this gender bias. Fatherlessness is the leading predictor of crime in a community. The less time a child spends with his/her dad the more likely the child will drop out of school, commit crime, abuse drugs or alcohol, become pregnant or commit suicide. (Father and Child Reunion, Warren Farrell, Ph.D.) We should be helping families stay together rather than fueling the already high divorce rate with financial incentives and ideological hyperbole. "WHY DON'T PEOPLE TALK ABOUT FEMALE SEX OFFENDERS...? Societal silence on this topic has allowed women who are molesting children to remain well hidden...female pedophilia comes to light either long after the fact, or if it is detected earlier, it is lightly dismissed...sexual abuse by women is rarely taken seriously. The sexual crimes that women commit against children are well cloaked. Most females who harm children with sexual abuse remain undetected, unpunished, and untreated...by one estimate, 1.5 million females and 1.6 million males in the United States may have been sexually abused by women. A British researcher estimates that one in each hundred males and one in each hundred females has been sexually abused by a female" (Female Sex Offenders, What Therapists, Law Enforcement and Child Protective Services Need to Know, by Julia Hislop, Ph.D., pages 29-30). LESBIAN ON LESBIAN battering relationships can be classified as situational, chronic, and escalating. At least one researcher, Michael Johnson, believes that lesbian on lesbian battering has little to do with taking on patriarchal family values. Another researcher, Claire Renzetti, identified seven factors: power imbalance, dependency, jealousy, intergenerational transmission of violence, substance abuse, internalized homophobia, and personality disorders (No More Secrets, Violence in Lesbian Relationships, by Janice L. Ristock, pages 56-57). One significant finding "...was that 66 percent of the 189 respondents knew of lesbians who had been in abusive relationships" (Ristock, page X). Some of Ristock's work caused her to note, "...we were often worried about causing more harm to lesbians and to feminism by speaking about the issue to publicly" (page X). "Preserving a gender-based analysis has been a central concern of the women's movement as we have tried to confront the overwhelming level of male violence against women" (page 4), the later of which is questionable relative to female violence against men and in our opinion seems to reinforce the implication established in the preceding sentence that lies by omission are necessary to protect the feminist agenda. "Several women who identified as butch in this study reported being victimized by their smaller femme partner. They spoke of the added difficulties they face of not being believed or being shamed because of the assumption made on the basis of their butch identity or appearance that they must be the one who is abusive" (page 50). There goes the men are bigger so they must be the abuser argument. Ristock, using a feminist postmodern framework (page 23), says "[Her] whole book is a refusal of the social science/social service drive to create all-explanatory models. [Her] point is that all such models, all monolithic understandings of abuse, are flawed. 'Mutual abuse' is wrong, 'power and control' is wrong, 'effects of patriarchy' is wrong when indiscriminately applied" (page XI). But, Ristock still points a finger at men regarding lesbian on lesbian battering, "Recent writings on the high incidence of abuse within First Nations communities examine a context of colonization that displays the extreme dynamics of domination and subordination, which then can translate into the more intimate relations of abuser and abused. These conditions of patriarchy, misogyny, heterosexism, racism, and colonization are overwhelmingly present in the lives of lesbians and all marginalized peoples" (page 55). Hmm... Interestingly, Elizabeth Tyler, a volunteer hygiene worker visiting slums to help mothers as part of "better babies" movement in the early 1900's, became one of the most powerful and influential of Ku Klux Klan leaders, male or female. She became rich from increasing KKK membership, dues, and donations. To do that, Tyler and companion Edward Clark expanded the Klan's enemies. "No longer were blacks the sole objects of Klan hatred. Now Catholics, Jews, nonwhites, Bolsheviks, and immigrants became targets" (Women of the Klan, Racism and Gender in the 1920's, by Kathleen M. Blee, page 21). Lulu Markwell became the first head of the national women's Klan, the WKKK with a chartered membership of 125,000 soon to balloon to 250,000 or more (page 29, Blee). "Markwell herself saw great possibilities for the Klan to further the interests of women as women, in addition to their racial and political interests. She noted that the Nineteenth Amendment granting women the vote had piqued women's interest in politics... Women now saw it as their duty to work 'in the maintenance of that amendment'" (page 32). Mainstream feminism has some intriguing roots. Before or after the ladies of the (W)KKK, many of who participated in lynching, came lovelies like Valerie Messalina (Roman Lolita), Agrippina the Younger (Empress of Poison), mass murder Catherine the Great (Empress of all the Russias), Elena Ceausescu, (Mother of the Fatherland, Romania), Tz'u-his (The Dragon Empress of China), Queen Ranavalona I (Bloody Mary of Madagascar), and a seemingly endless list of such women, including one very "no man made me do it" Elizabeth Bathory. Elizabeth is one of the most prolific, if not most prolific, sexual pleasure serial killers in recorded world history. At her castle Csejthe in Transylvania, little Ms. Bathory sexually abused, raped, tortured and murdered no less than 600 female servants. She was queen of sadists and reveled in bathing in the blood of her victims, as well as drinking it (The Most Evil Men and Women in History, by Miranda Twiss, see chapter on Bathory). And who can forget the infamous Ilse Koch who was known as the Bitch of Buchenwald for her bestial cruelty and sadistic behavior. She loved making lampshades, wallets, and other such things as gifts for friends - making them from the tanned hides of murdered Jews in her hubby's concentration camp. The ideological man-bad-woman-good myth list is endless and has to be run to ground like the KKK. Some who have read this far will surely say a misogynist wrote it -- a patriarchal, overbearing, ignorant, and control oriented woman-hater who just doesn't get it. Someone who is in a complete denial and desperately in need of reprogramming, that is batterer intervention, must have written this. Alas, that isn't it. It's pretty clear that facts don't always neatly fit into the "connected way of knowing" and "lateral thinking", but facts are facts. No matter how one tries to ignore or color facts with emotion, ideology, and "because-I-want-it-to-be-that-way thinking", nothing changes the fact that facts are facts -- nothing. Both are true and patently ridiculous. This is from 'A Feminist Dictionary', ed. Kramarae and Treichler, Pandora Press, 1985: \*MALE: ... represents a variant of or deviation from the category of female. The first males were mutants... the male sex represents a degeneration and deformity of the female.' \*MAN: ... an obsolete life form... an ordinary creature who needs to be watched ... a contradictory baby-man ... \*TESTOSTERONE POISONING: 'until now it has been thought that the level of testosterone in men is normal simply because they have it. But if you consider how abnormal their behavior is, then you are led to the hypothesis that almost all men are suffering from "testosterone poisoning." And, so it goes. Some still argue there's not such thing as "battered men syndrome"; like others believe there was no Holocaust. Are you uncomfortable yet? We expect your disdain.
